	<p>3. SLIDE 3 EXPLAIN FIGURE 2.2 Tags identify that the power has been removed and service work is being done.</p> <p>4. SLIDE 4 EXPLAIN FIGURE 2.3 All brakes should be moistened with water or solvent to help prevent brake dust from becoming airborne</p>
	<p>DEMONSTRATION: SHOW STUDENTS WET-DOWN PROCEDURE FOR BRAKES LIKE FIGURE 2-3</p>
	<p>DEMONSTRATION: SHOW STUDENTS HOW TO DISPOSE OF BRAKE FLUID</p> <p>DEMONSTRATION: SHOW CORROSIVENESS OF BRAKE FLUID BY POURING ON PAINTED OBJECT</p>
	<p>5. SLIDE 5 EXPLAIN FIGURE 2.4 A typical aboveground oil storage tank.</p> <p>6. SLIDE 6 EXPLAIN FIGURE 2.5 Washing hands and removing jewelry are two important safety habits all service technicians should practice.</p>
	<p>DEMONSTRATION: CUT TOP OFF OLD OIL FILTER. SHOW STUDENTS FILTERING ELEMENT & ALL OF PARTICLES IT HAS FILTERED. THIS IS REASON WHY YOU HAVE TO DRAIN FILTER BEFORE DISPOSAL</p>
	<p>HOLD DISCUSSION ON SOLVENTS USED IN SHOP. ASK STUDENTS TO DISCUSS COMMON SOLVENTS USED IN THE SHOP</p>
	<p>7. SLIDE 7 EXPLAIN FIGURE 2.6 Typical fireproof flammable storage cabinet</p> <p>8. SLIDE 8 EXPLAIN FIGURE 2.7 Using a water-based cleaning system helps reduce the hazards from using strong chemicals.</p>
	<p>9. SLIDE 9 EXPLAIN FIGURE 2.8 Used antifreeze coolant should be kept separate and stored in a leakproof container until it can be recycled or disposed of according to federal, state, and local laws. Note that the storage barrel is placed inside another container to catch any coolant that may spill out of the inside barrel.</p>
	<p>10. SLIDE 10 EXPLAIN FIGURE 2.9 This red gasoline container holds about 30 gallons of gasoline and is used to fill vehicles used for training.</p>
