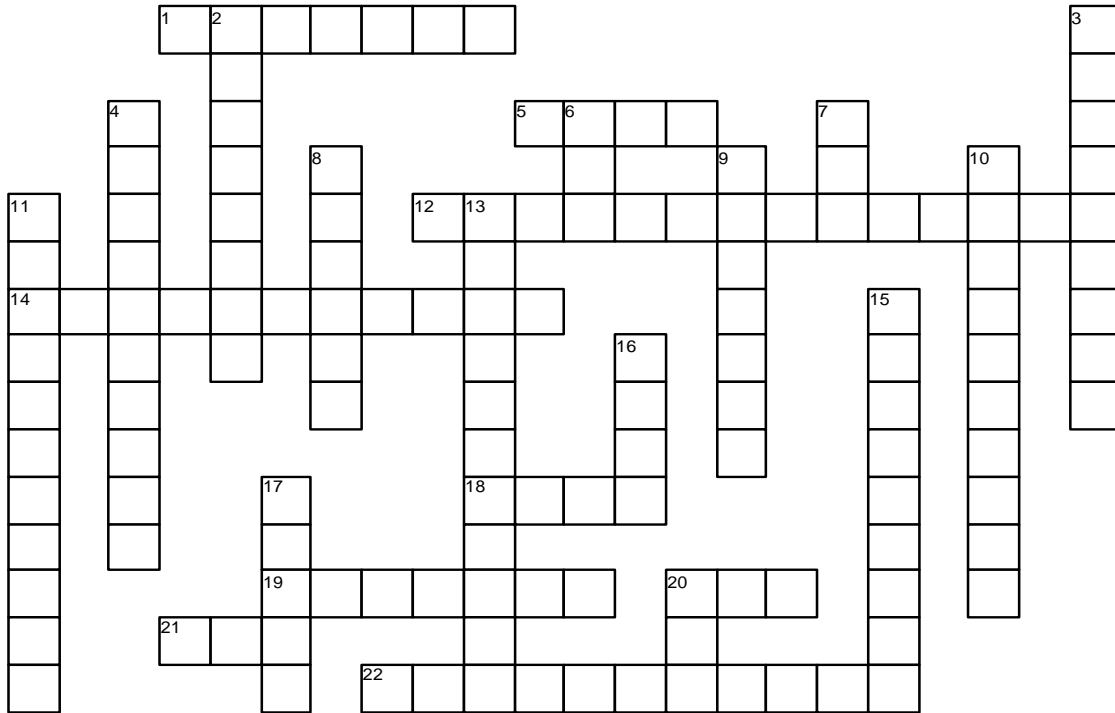

### ACROSS

- 1 \_\_\_\_\_ is any petroleum-based or synthetic oil that has been used.
